

# PRIVACY POLICY

- Hexogonal Foundation is committed to helping the underprivileged to gain access to quality healthcare (“Our Cause”) We welcome your charitable contributions and value your privacy and are committed to ethical collection, retention and use of information that you provide to us about yourself during the contribution process (“Personal Information”) on our website, <http://www.hexogonalfoundation.com> . This policy sets forth our terms and conditions and understanding regarding the collection, use and protection of your Personal Information that may be collected by us during the contribution process.
- Please note that by using of Website you consent to all the terms and conditions contained in this Privacy Policy and you shall be bound by the same.

- **COLLECTION OF INFORMATION**

- 1. Information We May Collect Which is not provided by you**

Hexogonal Foundation does not automatically collect your "IP Address" used to connect your computer to the Internet, browser type, version and operating system. However, it is likely that some of our Other Websites may collect your IP Address when you browse this Website.

Hexogonal Foundation does not use cookies (“Cookies”). However, it is likely that some of our Other Websites may enable Cookies to collect a user’s data. Cookies are small amounts of data, including an anonymous unique identifier, which are sent to your browser from a website’s computer and are stored on your computer’s hard drive.
